Summarize the proposed project.

With musician Max Weigert, I will create and implement four 40 min interactive community puppet and music workshops that will be presented at the East Somerville Library branch and the West Somerville Library branch (Once per month in each library from Feb to May 2018, for a total of 8 workshops) These workshops will invite families to contribute to the "play writing process" through interactive music, storytelling, and puppetry. This project will build on what Max and I learned from our 2016 Somerville project grant which allowed us to do a similar community engaged process - the results of which can be seen in all of the support material around the show "I Spy Butterfly"

The outcome of the 8 sessions will be a 30 min puppet show. I will offer the play to puppetpalooza (for 2018 season) and the growing center (for summer of 2018) for free.

Who is the target audience for this project?

I will engage families, children, youth, and educators in the 8 interactive sessions at the public libraries. The target audience for the final performances is "family audiences."

What is the cost of participation for attendees (if any)?

The interactive family sessions and culminating final performance(s) will be free to the public.

How does the proposed project provide public benefit and contribute to the cultural vitality of the community as a whole?

One of the main goals of this project is to bring puppet theater to public spaces in order to make it accessible to all peoples irregardless of race, gender, age, or socioeconomic background. I plan to work primarily in East Somerville. I will work closely with a Junior Youth group in Mystic (that Max Weigert is involved with) to strategize ways of engaging families in the interactive community puppet sessions.

Faye Dupras: holds a BFA in Drama and an MFA in Puppet Arts. She has an extensive background in community engaged art practices and is a teaching artist with over 20 years in the field. Max Weigert: He is a graduate of Berklee College of music. He is a singer songwriter and a children's performer. His CD "So Much to See" has received praise from parents, children, and presenters across New England.
